Regulations and Policies

If in our judgment, your dog requires immediate medical care we will attempt to reach you or your emergency contact, however we will also take your dog to a veterinarian or animal hospital to avoid any unnecessary suffering. You agree to be solely responsible for the payment of all medical bills for your dog and you release The Woof On Cortez, its officers, directors, agents, volunteers and employees of and from any and all responsibility for claims, damages, debts, etc., arising out of or related to any such medical care, including, but not limited to, transportation to/from the veterinary clinic and choice of veterinarian and animal hospital.

The Woof On Cortez reserves the right to immediately change your dog's type of boarding/daycare if we believe it is necessary to protect the health and well-being of your dog, other dogs, and/or our staff. If your dog begins to show behavior different from a previous visit, we reserve the right to segregate your dog from the rest of the dogs. Standard fees apply and your dog may have to be uninvited.

Your dog must be healthy and current on Rabies, DHPP (distemper, hepatitis, parainfluenza and parvovirus) and Bordetella. It is your responsibility to provide documentation before or at the initial visit and to also provide updated documentation as needed. For the safety of all of the dogs, we reserve the right to refuse service for any pet that is showing an expired vaccination in our system. If your dog is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, diarrhea, please do not bring your dog to daycare or boarding. If your dog develops symptoms during the stay, we will segregate your dog to protect the health of the other dogs.

You understand that the Bordetella vaccination doesn't eliminate the chances of your dog contracting kennel cough. It reduces the chances of contracting it and also helps lessen the severity if contracted. Kennel cough is the canine version of the human cold and just as with children in daycare it can spread quickly regardless of vaccination status and all we do at The Woof On Cortez to maintain a clean and sanitary environment.

You acknowledge and understand that there are certain risks involved in daycare and boarding, including but not limited to dog fights, dog bites to humans or other dogs and the transmission of disease. Additionally, any medical expenses will be your responsibility and you release The Woof On Cortez of any liability and charges.

All dogs must arrive on a leash and be wearing a quick release collar with a name tag. Pets without a quick release collar will be segregated to help ensure safe play for all other participants. No extendable leashes, choke chains, corrective collars, harnesses, or pet clothing is allowed in the play areas.

The Woof On Cortez reserves the right, without notice but not applicable during an already occurring visit, to adjust our fees, services and policies. All charges must be paid in full upon pick-up of your dog. Dogs left ten days beyond the agreed pick-up date without any communication from the owner or owner's representative will become the property of The Woof On Cortez.

- *** All dogs must pass a "First Day" before participating in daycare or boarding. These must be scheduled as we limit the number of new dogs per day. If your pup passes the "First Day", standard fees apply; if you pup doesn't pass, there is no charge.
- **Daycare is available 7 days a week. Drop-off is between 6am and 12pm, Monday Friday and 8am 12pm Saturday Sunday. Day play hours are 8am to 5pm and all daycare dogs are assigned a temporary kennel outside of these hours. Pick up is available as late as 8pm.
- **Boarding arrivals are available Monday Friday between 6am 8pm and Saturday Sunday between 8am 8pm. Standard check-out time is 12pm. Check-outs between 12pm 8pm will incur a full day of daycare per pet. Latest pick-up time is 8pm. Boarding dogs enjoy the same day play hours and amenities as daycare dogs at no additional charge other than the day of check-out. House food is available at \$2.00 per feeding but we encourage you to bring their own food and treats. Topical and Oral medicine is administered at no additional charge.

**HOLIDAYS, PEAK PERIODS, EMERGENCY SITUATIONS and WEATHER CONDITIONS MAY SOMETIMES AFFECT DAYCARE/BOARDING STAY AVAILABILITY, MINIMUM # OF BOARDING DAYS REQUIREMENT, HOURS, and PRICING. Announcements/Notifications will be made as early as possible.

C) INITIAL _____ This Agreement covers the current relationship between The Woof On Cortez and yourself. Each time you bring your dog to The Woof On Cortez, you affirm the terms of this Agreement, and the truthfulness and accuracy of all statements you have made in this Agreement.

D) INITIAL _____ This Agreement applies to all dogs on your account with The Woof On Cortez, regardless of the fact, that any additional dogs in your
